- Professional refrigerated storage cabinets to EN 16825 under regulations 2015/1094 and 2015/1095;
- Household refrigerators and freezers to EN 62552 under regulations 643/2009 and 1060/2010.

The EEPLIANT2 project unites market surveillance authorities from 15 EU Member States to work together to increase compliance with energy efficiency and ecodesign requirements. EEPLIANT2 covers the product groups of: household refrigerators, professional refrigerated storage cabinets and network standby.

The project involves joint monitoring, verification and enforcement activities across Austria, Bulgaria, Denmark, Finland, France, Germany, Ireland, Latvia, Lithuania, Luxembourg, Malta, the Netherlands, Portugal, Slovenia, and Sweden. It runs from September 2017 to February 2020 and is coordinated by PROSAFE and funded by the European Union under the Horizon 2020 framework.
